First, I want to thank you for all your efforts in making District 4 such a wonderful place to live, work and play. I am grateful for your continued efforts to engage with your communities and bring together volunteers to keep the city and our communities' places we can all be proud of.

In a time when money and resources are scarce, I know the work of the district 4 Coalition and each neighborhood association is critical to the livability in the district.
