- Bourget teams up with neighborhood associations and coalitions to pressure Portland's greatest polluters on a grassroots level
- PCA will dispatch portable particulate readers to collect data on diesel pollution across Portland. Neighborhood associations will be able to check these readers out
- Kohnstamm and Pinger express desire for fewer "political" presentations

- Savings in personnel and otherwise will likely be used to:
  - o Compensate for 1 percent cut from Civic Life and anticipated future cuts
  - Buy insurance for 2019/20
  - Purchase office necessities
- Board affirms Sieber's preliminary budget plan. Sieber will develop official budget proposal accordingly
